### Conditions:

1. The College shall abide by the provisions of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 and amended from time to time.
2. The College shall strictly abide by the Act, Statutes, Guidelines for Implementation of Academic Autonomy, Rules and Regulations of the Visvesvaraya Technological University (VTU), Belagavi as when it is revised/amended from time to time.
3. The College shall get its programmes accredited by the National Board of Accreditation (NBA) and National Assessment and Accreditation Council (NAAC) as and when it is mandated by the UGC, AICTE and VTU.
4. The College shall send annual returns to the University every year by 31<sup>st</sup> March in the format prescribed in Guidelines for Implementation of Academic Autonomy.
5. The College shall send the list of admitted candidates to the University for Approval and generation of University Seat Numbers immediately after reconciliation against the University notification in this regard.
